Application are invited from the eligible Officers for appointment to one post of Professor of Sugar Engineering a General Central Service, Group 'A' Gazetted, Non-Ministerial post in Pay Matrix Level-13, Cell-1, Rs. 1,23,100/- (as per 7th CPC) at National Sugar Institute, Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution, Kanpur. The post of Professor of Sugar Engineering is to be filled up on deputation (including short-term contract) from amongst officers under the Central or State Governments or Union Territory or Public Sectors Undertakings or Universities or recognised research Institutes or Semi Government or autonomous or statutory organization -

- A) (i) holding analogous post on a regular basis in the parent cadre /department; or  
(ii) with five years' service in the grade rendered after appointment thereto on regular basis in level - 12 in the pay matrix Rs. 78,800-2,09,200 or equivalent, in parent cadre/department; or  
(iii) 'with ten years' service in the grade rendered after appointment thereto on a regular basis in level-11 in the pay matrix Rs. 67,700-2,08,700, or equivalent, in parent cadre or department; and
- B) Possessing the educational qualification and experience as under:-

#### **ESSENTIAL:-**

- (i) Degree in Mechanical Engineering or Electrical Engineering from a recognised University or Institute or Associate Member of Institution of Engineers (AMIE) in Mechanical Engineering or Electrical Engineering;
- (ii) Associateship of National Sugar Institute in Sugar Engineering awarded by National Sugar Institute or post-graduate diploma in Mechanical Engineering or Electrical Engineering from Vasantdada Sugar Institute, Pune after completing degree in Mechanical Engineering or Electrical Engineering from a recognised University or Institute; and
- (iii) Ten years' research or practical or teaching experience at degree level in Mechanical Engineering or Electrical Engineering or Sugar Engineering.

#### **Desirable:**

- (i) Post-Graduate Degree in relevant branch of a Engineering from a recognised University or Institute;
- (ii) Three years' experience of designing or operation or erection of modern sugar plant.

**Note-1.-** The qualifications are relaxable at the discretion of the Union Public Service Commission, for reasons to be recorded in writing in the case of candidates otherwise well qualified.

**Note-2.-** The qualification(s) regarding experience are relaxable at the discretion of Union Public Service Commission for reasons to be recorded in writing in the case of candidates belonging to the Schedule Castes or the Scheduled Tribes, if at any stage of selection, the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities, possessing the requisite experience are not likely to be available to fill up the posts reserved for them.



The departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

The period of deputation (including short-term contract), including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed five years.

The maximum age-limit for appointment by deputation (including short-term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.

The place of posting will be National Sugar Institute, Kanpur (UP), but liable to be posted anywhere in India.

No application without proper channel will be entertained.

Candidates who once apply for the post will not be allowed to withdraw their candidature later subsequently.
