Applications are invited from the eligible officers for appointment to one post of Assistant Professor Sugar Engineering, a General Central Services Group 'A' Non-Ministerial post in the Level-11, (Rs. 67,700 – 2,08,700/- as per 7th CPC) at National Sugar Institute, Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution, Kanpur. The post of Assistant Professor Sugar Engineering is to be filled up by "Deputation (including short term contract)". Officers of the Central Government or State Government or Union Territory Administrations or Universities or undertakings or Semi- Government or autonomous bodies or Statutory Organizations, fulfilling the following:-

- (a) (i) holding analogous posts on regular basis in the parent cadre or department; or
 - (ii) With 05 (five) years' service in the grade rendered after appointment thereto on a regular basis in Level 10 in the pay matrix Rs. 56,100 − 1,77,500 or equivalent, in parent cadre or department; and
- (b) Possessing the educational qualifications and experience as under:-

Essential:-

- (i) Degree in Mechanical Engineering or Electrical Engineering from a recognised University or Institute or Associate Member of Institution of the Engineers (AMIE) in Mechanical Engineering or Electrical Engineering
- (ii) Associateship of National Sugar Institute in Sugar Engineering awarded by National Sugar Institute or post-graduate diploma in Sugar Engineering from Vasantdada Sugar Institute, Pune after completing degree in Mechanical Engineering or Electrical Engineering from a recognised University or Institute; and
- (iii) four years' practical or research or teaching or advisory experience of Mechanical Engineering or Electrical Engineering work in a responsible capacity, involving designing, erection and operation of upto-date sugar manufacturing plant.

Desirable:-

- Post-graduate degree in relevant branch of Engineering;
- (ii) One year experience of designing or operation or erection of modern sugar plant.
- Note 1: The qualifications are relaxable at the discretion of the Union Public Service Commission, for the reasons to be recorded in writing, in the case of candidates otherwise well qualified.
- Note 2: The qualifications(s) regarding experience are relaxable at the discretion of Union Public Service Commission, for the reasons to be recorded in writing, in the case of candidates belonging to the Schedules Castes or the Scheduled Tribes, if at any stage of selection, the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

The period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed four years.

The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date of the receipt of applications.
