Applications are invited from the eligible candidates for appointment to the Post of Farm Superintendent, General Central Service (Group 'C') Non-Gazetted, Non-Ministerial post in Pay Matrix Level-5, Cell-1, Rs. 29,200 - 92,300/- (as per 7th CPC), on deputation (including short term contract) basis at Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution, National Sugar Institute, Kanpur. The post of Farm Superintendent is to be filled up on deputation (including short term contract) amongst the following candidates:-

#### Deputation:

Officers of the Central Government or State Government or Public Sector Undertaking, Semi Government, Autonomous or Statutory Organisations, recognized Research Institutions of repute or Councils:-

- (a) (i) holding analogous posts on a regular basis; or
  - (ii) with five years' service in the posts in Level-4 in the Pay Matrix; and
- (b) Possessing the educational qualifications as are under:-

#### Essential:

- (i) B.Sc. Agriculture from a recognized University or Board or equivalent.
- (ii) Five years experience is managing a large Government or Semi-Government or Society or Private Agriculture Farm.
- Note 1:- Qualifications are relaxable at the discretion of the Staff Selection Commission or Central Government in case of candidates otherwise well qualified.
- Note 2:- The qualifications are relaxable at the discretion of the Staff Selection Commission or Central Government in case of candidates belonging to the Scheduled Castes or Scheduled Tribes, if at any stage of selection, the Staff Selection Commission or Central Government is of the opinion the sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

The departmental Agriculture Supervisor in level-4 of the Pay Matrix with five years regular service in the grade will also be considered along-with deputationists. In case he is selected for appointment, the post shall be deemed to have been filled by promotion.

- **Note 1:-** The departmental officials in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- Note 2:- Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.
- Note 3:- The maximum age limit for appointment by deputation (including short term contract) shall be 'not' exceeding 56 years' as on the closing date of receipt of applications.

The place of posting will be National Sugar Institute, Kanpur (Uttar Pradesh) but libel to be posted anywhere in India.
