It is proposed to fill up one post of Senior Technical Assistant (Sugar Technology), a General Central Service (Group 'B') Non-Gazetted, Non-Ministerial in the Pay Matrix Level-6, Cell-1, Rs. 35,400-1,12,400/- (As per 7th CPC), [Pay Band-2, Rs. 9300-34,800/- with grade pay of Rs. 4200/- as per 6th CPC (pre-revised pay scale of Rs. 5500-175-9000)] at National Sugar Institute Kanpur, Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution on deputation (including short-term contract) basis. The post of Senior Technical Assistant (Sugar Technology) is to be filled up on deputation from amongst candidates Officials of the Central Government fulfilling the following:-

Deputation (Including Short-Term Contract):

Officers under the Central/State Government/Union Territories/Universities/Recognized Research Institutions/Public Sector Undertaking/Semi-Government/Statutory or Autonomous Organizations:-

- (a)(i) Holding analogous posts on regular basis in the parent Cadre/Department; Or
- (ii) With three years' service in the grade rendered after appointment thereto on a regular basis in the pay Matrix Level-6, Cell-1, Rs. 35,400-1,12,400/- (As per 7th CPC), [Pay Band-2, Rs. 9300-34,800/- with grade pay of Rs. 4200/- as per 6th CPC (pre-revised pay scale of Rs. 5500-175-9000)] scale of Rs. 5,000-8000/- or equivalent, in the parent Cadre/Department; Or
- (iii) with six years service in the grade rendered after appointment thereto on a regular basis in the pay Matrix Level-5, Rs. 29,200-92,300/- as per 7th CPC, [Pay Band-1 Rs. 5200-20200/- with Grade pay Rs. 2800/- (pre-revised pay scale of Rs. 4500-7000 or equivalent, in the parent Cadre/Department;

and

(b) Possessing the educational qualifications and experience as under:-

Essential:

Degree in Science/Engineering with (i) Associateship in Sugar Technology awarded by National Sugar Institute, Kanpur or (ii) Post Graduate diploma in Sugar Technology from a recognized University/Institute or equivalent.

Desirable:

- (i) Practical experience in a Sugar factory as a manufacturing chemist or Research/Practical Experience in research institution of a Government organization.
- (ii) Teaching Experience.

Note: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for, consideration for appointment on deputation.

Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not exceed three years.

The maximum age limit for appointment by deputation (including short term contract) shall be 'not' exceeding 56 years' as on the closing date of receipt of applications.

2. For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the Sixth Central Pay commission has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said pay Commission except where there has been merger of more than one perrevised scale of pay into one grade with a common grade pay or pay scale and where this benefit will extend only for the post or posts for which that grade pay or pay scale is the normal replacement grade without any upgradation.

The place of posting will be National Sugar Institute, Kanpur (Uttar Pradesh) but libel to be posted anywhere in India.

No application without proper channel will be entertained.

Candidates who once apply for the post will not be allowed to withdraw their candidature later subsequently.

- (iv) A certificate to the effect that no major/ minor penalty has been imposed to the officer during the last 10 (ten) years under Central Civil Services (Control, Classification and Appeal) Rules 1965.
