Applications are invited from the eligible candidates for appointment to the Post of Upper Division Clerk, General Central Service (Group 'C') Non-Gazetted, Ministerial Post in Pay Matrix Level-4, Cell-1, Rs. 25,500-81,100/- (as per 7th CPC), [Pay Band-1, Rs. 5200-20,200/- with grade pay of Rs. 2400/- as per 6th CPC] on deputation basis at National Sugar Institute, Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution, Kanpur. The post of Upper Division Clerk is to be filled up on deputation from amongst candidates Officials of the Central Government fulfilling the following:-

Deputation:

Officers of the Central Government:

- (i) holding analogous post on regular basis in the parent cadre or department; or
- (ii) Lower Division Clerk in the Pay Matrix Level-2, Rs. 19,900-63,200/- (as per 7th CPC), [Pay Band-1, Rs. 5200-20,200/- with grade pay of Rs. 1900/- as per 6th CPC] with eight years' regular service in the grade.
- **Note 1:-** The departmental officials in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.
- **Note 2:-** Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.
- **Note 3:-** The maximum age limit for appointment by deputation shall be 'not' exceeding 56 years' as on the closing date of receipt of applications.
- Note 4:- For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the Sixth Central Pay commission has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said pay Commission except where there has been merger of more than one per-revised scale of pay into one grade with a common grade pay or pay scale and where this benefit will extend only for the post or posts for which that grade pay or pay scale is the normal replacement grade without any up-gradation.

The place of posting will be National Sugar Institute, Kanpur (Uttar Pradesh) but libel to be posted anywhere in India.

No application without proper channel will be entertained.

Candidates who once apply for the post will not be allowed to withdraw their candidature later subsequently.
