NOTIFICATION

New Delhi, the 17th April, 1990

G.S.R. 288.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the National Sugar Institute, Kanpur (Group 'A' and Group 'B' posts) Recruitment Rules, 1964, namely:—

1. (1) These rules may be called the National Sugar Institute, Kanpur (Group 'A' and Group 'B' Posts) Recruitment (Amendment) Rules, 1990;

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the National Sugar Institute, Kanpur (Group 'A' and Group 'B' Posts) Recruitment Rules, 1964 after the serial number 56 relating to the post of the Chief Administrative and Finance Officer and the entries relating thereto, the following serial number and entries shall be added, namely:—

NOTE :

Suitability of the regular holder of the post of Stenographers Grade-I in the pre-revised scale of Rs. 1640-2900 prior to upgradation of this post in the scale of Rs. 2000-3200 will be initially assessed for appointment to the upgraded post. If assessed suitable, he shall be deemed to have been appointed to the post at the initial constitution. If assessed not suitable for appointment to the upgraded scale of pay, he shall continue to be in the scale of Rs. 1640-2900 and his case would be reviewed every year till such time the officer is found fit for holding the post in the higher grade namely Rs. 2000-3200.
